In order to qualify for a mobile license, you must be a holder of a valid cosmetology license. The mobile license will enable you to perform cosmetology services outside of a registered salon, such as a client's home, office, hotel/motel, but excluding hospitals and nursing homes where an established salon is designated to the residents of the home or patience of the hospital.

POLICIES #2	INFECTION CONTROL AND PREVENTION	YOUR INITIALS
A	Implements and equipment which are or may be used on more than one customer and which come in direct contact with the customer must be thoroughly cleaned after each use and be maintained in a clean condition at all times.	
B	Implements used for cosmetology services, after final use on a client and before being used on another client must be rinsed and washed immediately after and subjected to an appropriate disinfectant in accordance with the manufacturer's instructions, then stored in a clean covered space.	
C	Wax pots must be covered, and only single use disposable applicators are permitted for all waxing services; no double dipping	
D	Gloves should be available for employees to use when needed.	
E	Porous items must be discarded after each use	
I	Cosmetologists must wash their hands thoroughly before performing a service.	
K	Cosmetologists must have a covered container for disinfection purposes.	

POLICIES #3	MOBILE	YOUR INITIALS
A	Cosmetologists wishing to offer services outside of the cosmetology salon must obtain a mobile license by submitting an application, paying the required fees and adhering to the infection control/prevention policies.	
B	A valid mobile license must be included with your carrying case and must be renewed annually.	
C	Mobile equipment is used to provide mobile cosmetology services and is not permanently fixed in a cosmetology establishment.	
D	Anyone performing mobile services for more than 10 hours per week will be required to possess a mobile license which will be renewed separately from other licenses and permits.

**METHOD OF PAYMENT**

I have enclosed a cheque or money order, in the amount of **\$224.00**, for the mobile application fee and **\$60** for the permit.

I have paid with a credit card, on the website or over the phone, in the amount of **\$224.00**, for the mobile application fee and **\$60** for the permit.

Once the mobile application is approved, you will receive your mobile license and certificate by mail. Your mobile cosmetology license will be valid for one (1) year and must be renewed prior to the expiry date. The annual renewal fee for the mobile cosmetologist is \$140.00 (\$60 for the mobile license, and \$80 for the cosmetologist license).

I have read the rules and regulations for a mobile cosmetology license and I understand that the mobile license does not permit me to offer cosmetology services in my personal residence. I agree that, upon receiving said license, I will abide by all by-laws and regulations for a mobile license and the sanitation/disinfectant requirements set forth by the COSMETOLOGY ASSOCIATION OF NEW BRUNSWICK.
